William Angliss Institute Singapore Office is responsible for the admission, orientation and welfare of all international students. The office provides advice on matters relating to program admission, student visa regulations, payment of fees and further studies.

International Student Course Coordinators

Singapore offers a diverse community of Chinese, Malay, Indian and other cultures, covering a wide spectrum of religions, cultures, and languages all living harmoniously together.

Food

Singapore is commonly known as a "Food Paradise!" Shopping and food are considered to be national pastimes in Singapore. There are venues to suit all budgets and tastes, ranging from the popular hawker centres and coffee shops to chain restaurants, quirky cafes, contemporary restaurants and fine dining options across the island.

Meal prices range from Hawker Centres (S\$3.50-7.00 per meal) with lots of food stalls grouped together to Food Courts (S\$5-10 per meal) in malls to Restaurants (S\$20 - 30 and above per meal).

Safety

Singapore excels in safety and cleanliness. The city streets and public transportation methods are exceptionally secure for students and well supported with strict laws.

Weather

Singapore's climate is warm and humid, with temperatures ranging from 23 to 33 degrees Celsius. The country has plenty of sunshine, with the occasional rainstorm, especially during the year end periods. Our Singapore campus is airconditioned year-round.

Public Transport

Public transport is affordable and efficient. Travelling from one part of Singapore to another is easy thanks to a highly penetrative public transport system. The three main modes of public transport in Singapore are the Mass Rapid Transit (MRT), buses and taxis.

Overall Cost of Living

The cost of living in Singapore is generally reasonable for such a developed country. As a student it is important to budget wisely in order to live at a standard you are comfortable with. Following is a basis of what you can expect to spend each month. Actual expenses vary with each student, according to individual lifestyle and preferences.

Note: The living cost does not include tuition fees and travel expenses from your home country to Singapore.

Students must consult student support services team before making any bookings or signing long term accommodation contracts. Student must not book long-term accommodation offshore.



Currency

The official currency of Singapore is the Singapore Dollar (SGD).

Good and Services Tax (GST)

A 8% Goods and Services Tax (GST) is imposed on all purchases. Tipping is not commonly practised in Singapore as most restaurants and hotels have a 10% service charge on bills.

Medical

A visit to a General practitioner (Doctor) costs approximately S\$30-50 for a consultation, depending if further treatment is required. We recommend students research their insurance scope, and the processes to manage your medical needs for the period of your studies.

Drinking Water

It is generally safe to drink water straight from the tap, according to pub.gov.sg.

Electricity

Singapore uses the square-shaped three-pin plug. You may need an adapter or transformer for foreign appliances, which are available at most hardware and supermarket stores.

Entry Requirements

Academic requirements

William Angliss Institute Singapore academic entry requirements must be demonstrated by ONE of the following:

Other qualifications are happily considered on a case-by-case basis.

If you have not completed your secondary studies, you need to be at least 21 years of age with demonstrated capacity to meet course requirements and relevant work experience.

Age requirements

Applicants must be 17 years of age or above.

William Angliss Institute does not accept students who are under 17 years of age.

Note: For students under 18, there is no guardianship requirement for travel and accommodation arrangements to Singapore. It is an industry practice for international students below the age of 18 years old to have a parent or legal guardian appointed to sign off legal documents, in particular the student contract.

Student Pass Requirements

International students are permitted to study on campus in Singapore after their Student's Pass is approved.

- 3. Birth Certificate
- 4. Your personal information, including the list of countries / places you have previously resided.
- 5. Educational background
- 6. Employment history (if applicable)
- 7. Financial support
- 8. Your parents', spouse's, and / or siblings' personal information (if applicable)
- 9. Your residential address and contact details in Singapore
- 10. Your email address
- 11. Your recent, passport-sized, digital, colour photograph taken within the last three months. Please refer to the photo guidelines for more information.

The processing time for a new Student's Pass application is within one month (and within two weeks for an EduTrust-accredited PEI) (excluding the date of submission).

Policies and Procedures

Personal Data Protection Act (PDPA)

The Personal Data Protection Act (PDPA) 2012 establishes a data protection law that governs the collection, use, disclosure and care of personal data. William Angliss Institute, Singapore is responsible for the personal data in its possession or under its control, and will develop and implement policies and practices that are necessary for the Institute to meet the obligations under the Personal Data Protection Act (PDPA) 2012. The Institute is to ensure that individual data is secure at all times and safe from unauthorized access. alteration. use or loss.

Fee protection scheme

The Fee Protection Scheme (FPS) serves to protect the students' fees in the event a Private Education Institution (PEI) is unable to continue operations due to insolvency, and/or regulatory closure. Furthermore, the FPS protects the student if the PEI fails to pay penalties or return fees to the student arising from judgments made against it by the Singapore courts. FPS is compulsory for both local and international students taking courses unless a waiver is granted by CPE.

Medical Insurance

Student must have medical insurance policy before travelling to Singapore. A proof of student's medical insurance policy is to be submitted to the Institute before travelling to Singapore. The insurance policies annual limit must not be less than S\$20,000 per student, and the policy must provide at least B2 ward coverage (in Singapore government / Singapore government restructured hospitals).

Standard Student Contract

The Standard PEI-Student Contract ("Student Contract") WAI, Singapore adopts is a very important legal document between the Institute and the student.

It is the responsibility of the Institute to explain the following contents of the student contract in English or in the native language of the student, where applicable.

- Course information and Fees (i)
- (ii) Refund Policy, including Refunds for Withdrawal for Cause and Refunds for Withdrawal without Cause
- (iii) Fee Protection Scheme by Insurance
- (iv) Any other information as deemed necessary

All students are required to sign two original sets of student contract. One set will be given to the student and one set will be kept by the Institute. If any amendment is made which will change the original intent of the student contract, both the student and WAI, Singapore must sign beside the amendment(s) on both sets of the original student contracts.

Student Transfer/ Withdrawal and Deferment Policy

- 1. The policy on transfer/ withdrawal / deferment:
- 1.1 A student who requests for an internal course transfer within the Institute must have their existing

contract terminated. A new student contract will be signed based on the procedures for executing student contracts.

- 1.2 A student who transfers from his / her current course to another course within the Institute shall be deemed to have withdrawn from the Course and the Refund Policy shall apply unless as otherwise agreed between the Institute and the Student.
- 1.3 All requests must be made in writing. Verbal notices will not be accepted.
- 1.4 The student must also fulfil all the admissions criteria of the new course and will be subjected to the Institute's student selection and admission procedures.
- 1.5 A student who withdraws from the Institute to enroll with another Institute shall be deemed to have withdrawn from the Institute and the refund policy and procedures shall apply.
- 1.6 A student who requests a deferment of course /unit is required to submit Deferment Request Form with supporting documents. An interview will be conducted by Student Services Team and is subject to approval by the Academic Department. An Official Letter of Acceptance or Rejection will then be issued to the student. The deferment fees are calculated as a base fee of S\$ 248.40 + S\$ 5.40 per unit hour.

2. Conditions for granting of Transfer and Withdrawal:

- 2.1 All outstanding fees must be settled
- 2.2 Submission of any supporting documents and adhering to the process as stated in the Course Transfer and Withdrawal Procedures.

3. Conditions for Refund

The Institute's Refund Policy shall apply for all qualified refunds. Students are to refer to the Institute's Refund Policy and the Standard Student Contract for further details.

4. Student Pass Status For Course Transfers

For Student Pass holders, course transfer is subject to ICA's approval of the new Student's Pass. In the event that an application pertaining to transfer is rejected by ICA, the student is required to cancel his current Student's Pass within 7 days.

- 5. For Course Withdrawals Student Pass holders are required to submit his / her passport and Student Pass to the Institute for cancellation of Student Pass with ICA.
- 6. Timeframe for assessing and processing transfer / withdrawal cases.

The entire transfer / withdrawal process, from point of application to the final outcome, should not be more than 4 weeks. If the final outcome is not in favour of the applicant, respective staff are to handle each situation according to the Institute's dispute resolution policy and procedure.

Suspension of Studies

The Institute has the right to suspend a student from his / her course of study under the following unsatisfactory conditions:

- Misconduct or unacceptable behaviors
- Repeated poor academic performance
- Violation of the Institute's policies
- Financial Reasons
- Suspicion or confirmation of infectious or contagious disease

Student will be informed that his / her study has been suspended and will be notified of the reason(s) for the suspension. Where appropriate, the student will be given a return-to-study date and informed of any conditions that must be met before he / she can resume study.

Student identified with any of the above condition(s) will undergo investigation and

counselling. The student may appeal to the Institute within seven (7) days from the date of notification of the suspension. The appeal will be reviewed by the panel that comprises of the Trainer-in-charge, Academic HOD and Centre Director.

Expulsion

- Institute:
- Cheating during assessments
- Unrepentant behaviour after undergoing counselling
- Student Pass being cancelled by ICA for whatever reason(s)
- Student with repeated poor academic performance and unresponsive to academic assistance and counselling offered by William Angliss Institute
- No improvement or repeat occurrence of suspension of study condition
- Action or behaviour which is threatening, abusive or likely to cause alarm, harassment or distress
- Violation of Singapore law

- Student is not contactable for more

Student will be notified of the reason(s) for expulsion. The student may appeal to the Institute within seven (7) days from the date of notification of the expulsion. The appeal will be reviewed by the panel that comprises of the Trainer-in-charge, Academic HOD and Centre Director. The decision of the panel shall be final.

In the event that the student is expelled from the course by the Institute, there will be no refund of any course fees.

Course Fees and Additional Expenses

Courses are offered to International students in terms. Fees are not determined on a single subject basis but for places in entire courses which are designed by the Institute to ensure graduates maximize their career opportunities. For future stages of your course, the Institute reserves the right to adjust your annual course fees to take into account increases in Institute and course delivery costs.

In relation to course fees from an international student or an intending international student either in Singapore or overseas, the following statements apply.

1. Payments

- 1.1 Student's pass processing fee (S\$216) is non-refundable.

- It terminates the Course before the Course Completion Date;
- It has not ensured that the Student meets the course entry or matriculation requirement as set by the organisation stated in Schedule A of the standard student contract within any stipulated timeline set by CPE; or
- The Student's Pass application is rejected by Immigration and Checkpoints Authority (ICA).

The Student should be informed in writing of alternative study arrangements (if any), and also be entitled to a refund of the entire Course Fees and Miscellaneous Fees already paid should the Student decide to withdraw, within seven (7) working days of the above notice.

Refund for Withdrawal Due to Other Reasons:

If the Student withdraws from the Course for any reason other than those stated in Clause 2.1 of the standard student contract, the PEI will, within seven (7) working days of receiving the Student's written notice of withdrawal, refund to the Student an amount based on the table in Schedule D of the standard student contract.

Refund During Cooling-off Period:

The PEI will provide the Student with a cooling-off period of seven (7) working days after the date that the Contract has been signed by both parties.

The Student will be refunded the highest percentage (stated in Schedule D of the Standard Student Contract) of the fees already paid if the Student submits a written notice of withdrawal to the PEI within the cooling-off period, regardless of whether the Student has started the course or not.
